NOTICE OF RACE**

RegattaPRO, a corporate member of the United States Sailing Association, organizes this series.

The Racing Rules of Sailing and the Prescriptions of US Sailing shall govern this entire series.

Race dates shall be November 14th, December 12th, January 9th and February 13th. Two races per day are scheduled. If conditions allow, individual fleets may opt for a third race each day. The intended racing area will be north of Treasure Island outside the Berkeley Circle area. Warning Gun will be at 1130 hrs each day.

Courses will be windward/leeward courses set up using inflatable marks.

The low point scoring system RRS A4 shall be used. A minimum of one race shall be completed to constitute a series. If four races are completed, each yacht's worst score will be excluded. If seven or more races are completed, each yacht's two worst scores will be excluded. This series shall be scored as a series longer than a regatta.

Entry is open to One Design yachts, designated as 24' or greater in length and members of their class association. A minimum of three yachts is required for a class to participate. To qualify, classes must meet the minimum by Tuesday, November 10th.

Competitors may enter by mailing the entry form to: RegattaPRO, 3001 Bridgeway Blvd. #K-249, Sausalito, CA 94965. Entry fee is \$120 if postmarked by November 7th. Entry fee for entries postmarked after November 7th is \$140.
