



## **BAMA Starts Regatta**

### **NOTICE OF RACE**

Organizing Authority: RegattaPRO, a corporate member of US Sailing

This regatta is designed to give boats practice at starting. We will run as many starts as we can, with every third start being a "race" to the windward mark and back. This will allow you to see not only how close you were to the line at the gun, but also how your tactics at the start paid off at the windward mark. The windward mark will be approximately 1/4 nm upwind.

#### **1 RULES**

- 1.1 The regatta will be governed by the rules as defined in *The Racing Rules of Sailing*.
- 1.2 The Prescriptions of US Sailing will apply.

#### **2 ELIGIBILITY AND ENTRY**

- 2.1 The regatta is open to all multihull boats, who are members of the Bay Area Multihull Association.
- 2.2 Eligible boats may enter by completing the attached Entry Form and sending it, together with the entry fee of \$50.00, to RegattaPRO, 3001 Bridgeway Blvd., Ste. K-249, Sausalito, CA 94965 by February 15, 2010.
